We say these words as we come together during every Sunday service. They are true on many levels, including the financial level. We need each other to create and sustain this religious community which in turn nurtures us and enables us to go out and make a more just and sustainable world.

By working together we can accomplish great things. By joining together in a financial commitment to Edmonds Unitarian Universalist Church (EUUC), we can realize the church we want. Our financial support provides us with an inspiring minister, a thriving religious education program, a stirring music program, the administrative support to carry out all our programs, and a welcoming physical space.

## What level of giving is right for you?

Determining the amount to give requires both our hearts and our heads.

This giving guide, designed by the Unitarian Universalist Association, provides guidelines that factor in levels of commitment and financial capability. It recognizes that each of us live with a unique set of financial considerations—both our income levels and our financial obligations are different. It also recognizes the wide range of our commitment to EUUC—from the casual visitor to those for whom the church is a central part of their lives.

## How to use this giving guide

Begin by thinking about the importance of EUUC in your life. Does this church help you live out your spiritual values? Does EUUC play a role in defining who you are and how you live? Are you committed to sustaining the programs offered at the church?

How important is the volunteer work you share with others at EUUC? Are the sermons, committee work, and interest groups an important source of social and intellectual enjoyment in your life? Do you value the friendships you have made? Does EUUC provide joy? Are you excited about what EUUC can yet become?

Next, calculate your Adjusted Annual Income from the worksheet below. Then, use the table to find the suggested level of giving for your income level and to reflect the value of EUUC in your life.
